**HIGHWAY DEPARTMENT REPORT:**

Highway Commissioner Czernek reported that the first snow was November 21<sup>st</sup> and that we had 11 ½ inches of snow. The Highway Department worked 16 hours and used 90 ton of salt. There is no snow predicted for the near future and salt supplies are in good shape.

The Highway Department has purchased a chipper truck to help dispose of limbs in the Township that come down during these heavy snow storms and also general clean up when needed. They also took delivery of two new dump trucks.

The Highway Department was offered clean fill for free. This will save them money on fill needed for storm sewer jobs. Highway Commissioner Czernek will also offer some of the fill to our local villages if needed.

Electronic recycling has ended for the year. A total of 16,000 pounds were collected. The Highway Commissioner is still negotiating for a new contract for next year, and will have to make a decision soon.

During construction on Rohlwing Road, a street light was removed at the corner of Woodview Drive and Rohlwing Road. This is a very dark area and the residents have been trying to get it replaced for safety sake. Highway Commissioner Czernek was able to get help from Senator Durbin's office to get the street light put back soon.
