### **HIGHWAY DEPARTMENT REPORT:**

We are trying to wrap up all construction by the end of this month we have a little bit more to go. We have to do some work in the lot behind us. Pushing dirt back there.

The first week of November we will be doing restoration of sod.

We had an inspection on our fill site by the DuPage County Environmental Division and Illinois Environment Protection Agency, the purpose for the inspection was to make sure that we are in compliance with ethical requirements of the Illinois Environmental Protection Act Number 35 Illinois administrative code subtitle G. (testing of the dirt). There were no violations found and everything was clean, we had a good bill of health. So, we are going to close it out for the End of the year.

Our final Brush pick up is the week of October 21, 2019. That will be it for this year.

Electronic Recycling will be Saturday, November 23, 2019. From 8:00 a.m. until 12:00 p.m.

The Sheriff called the Highway Commissioner regarding speeding on Nordic Road. A speeding car took down the arrow signs, went through the Medinah fence and ended up on the fairway. They know who it was. We are going to file a claim for our signs and Medinah will be filing a claim for their fence and the turf that was torn up. The Sheriff's Department will be working with Glendale Heights on this matter. They know that the car was from Glendale Heights.

That is all he had. Supervisor Hovde thanked him for his report.

Marlene O'Malley, 7N421 Linden Avenue, Medinah, IL 60157 She read letter that was sent to the sheriff, regarding the traffic issues on Linden Avenue, Medinah.

Melinda Karalus, 22W220 Thorndale Avenue, Medinah, IL 60157 She spoke about traffic issues on Linden Avenue in Medinah. Would really like to see speed tables or speed humps. The Deputy has been very helpful, but cannot be there all the time. His shift ends at 3:00 p.m. and they are experiencing problems during evening rush hour.

Karl Haiden, 2N150 Diane Avenue, Glen Ellyn, IL 60137 A member of Glen Ellyn Countryside Homeowner Association. Discussed traffic issues. What would it take to get a secondary patrol from the Sheriff's Office? This would help alleviate some of the traffic issues.

George Magdanz, 7N300 Linden, Medinah, IL 60157 Traffic issues on Linden. Thorndale and Linden, we need a stop sign there. He would also like to see signs stating that Children are Present, to slow people down.

Kim Kaufman, 22W363 Turner, Medinah, IL 60157 Traffic issues on Turner Avenue. Cutting from Roselle through Medinah, as if it is a pass through, going west to east. The people know that there is no penalty, so they keep doing it.

Emelina Korzeniewski, 22W218 Temple Drive, Medinah, IL 60157 Traffic issues. Test drives from the dealerships. A lot of speeding.

Supervisor Hovde wanted to thank everyone for speaking. Supervisor Hovde, commented that we do not have a police force, so we did contract with the DuPage County Sheriff, to add what they call a Special Police Patrol. However, Du Page County Sheriff is supposed to patrol our streets even if we have the special patrol. Special Patrol is an officer who is assigned to our township for 40 hours a week.

We can investigate adding another officer or a different shift, something like that. We will look into it for the next meeting. As far as signs and speed bumps, he cannot speak to those.

Sebastian Wrobel, 22W345 Crest Avenue, Medinah, IL 60157 His parents were hit and run pulling into his driveway. We need to slow them down. We all are here representing Medinah, different areas of Medinah that need help.

Supervisor Hovde commented that the Township does not govern the roads, there are other agencies that determine where signs go.

Highway Commissioner Czernek commented that any traffic control signage that the Township puts up we need approval from Du Page County Engineer. They do not consider a stop sign a means to slow traffic down. They do accident studies to see if a stop sign is warranted, they don't do a stop sign to slow traffic down. The stop sign at Crest Avenue was installed because of the school bus stop.

The Highway Commissioner got a memo from IDOT to take down all the Children at Play signs. He said that IDOT said it encourages children to play in the street. However, the Highway Commissioner is NOT taking down any children at play signs. Enforcement is the main issue. To get extra patrols out there, he doesn't know what can be done.

The residents want to know who do we need to contact about signs?

Gail Mancini, 6N104 Acacia Lane, Medinah, IL 60157 Traffic issues and issues with cars going around the lake at night.

They wanted to know when it would be placed on the ballot.

Supervisor Hovde told them that they should come to the November meeting, for more information. We can suggest to the Sheriff where to patrol. But we don't have control. They asked for the Supervisor to check on signs that the residents can put in their yards to slow people down. He mentioned that those were related to a recent election.

Katie Mancici, 6N104 Acacia Lane, Medinah, IL 60157 Traffic issues and drivers not paying attention. We need more attention everywhere.

Supervisor Hovde recommended that the residents make the Sheriff aware of the traffic problems. He said there will be an update at the November meeting. They are also welcome to go to the County Board meetings that are held in Wheaton.

### **MENTAL HEALTH BOARD UPDATE:**
