HIGHWAY DEPARTMENT REPORT:

Highway Commissioner Czernek reported that on Saturday, April 1st they began the Electronic Recycling program again. They collected 16.31 tons of electronics. Last year in April they collected 17.75 tons, so there was a decrease from last year. One employee broke a finger.

They recently took care of an emergency sewer collapse in Conestoga Estates. This was a 30 to 40 year old sewer made of brick and mortar. Another sewer collapsed in Roselle with water pooling. They will put in a storm sewer and pipe to help drain the area into the Roselle system. There was another sewer issue in Glen Ellyn Country Side by the Park District. They will repair this to help prevent the water flooding over the road by the Park District.

There have been issues with front and side yard flooding in Glen Ellyn Country Side and Du Page County will come out to address this and advise what needs to be done.

There is a section North of Broker Road in Medinah where the infrastructure is starting to fail. We will be repairing 43 storm sewer inlets. We will also be working on the curbs and paving the subdivision starting in mid-May. We have been working on this for 14 months.

Brush pick up will start May 1st, notices have been sent out.

Salt has been ordered for next year. We were able to order at last year's price. Highway Commissioner Czernek noted that motor fuel tax will be used to pay for this.

HIGHWAY DEPARTMENT REPORT (Continued)

In mid-May there will be a paving meeting regarding twenty-two streets that we want to pave. In house we will be replacing 50 culvert pipes. That is all that can be done in one season. We have started a list for what to replace next year.

Four men will be attending a special safety class on mowing that DUDOT is conducting. The Highway Commissioner received a call from DuPage County about a street stripping contract that we can piggy-back on.

The Highway Commissioner noted that he will be attending Topics Day in Springfield regarding the importance of township Government.
