

ORDINANCE NO. 24-03

AN ORDINANCE ESTABLISHING
SALARIES FOR TOWNSHIP ELECTIVE OFFICES

WHEREAS, the elective offices of the Township of Bloomingdale are set for election on the 1st day of April, 2025; and

WHEREAS, it is the intention of the Board of Trustees to increase the compensation paid to the officials elected, so as to not suffer an economic disadvantage in comparison to adjustments to the cost of living; and may be amended in accordance with 50 ILCS 145/2 and 60 ILCS 1/80-35; and

WHEREAS, the electors of Bloomingdale Township previously approved by binding referendum, the abolition of the Bloomingdale Township Road District, with all rights, powers, duties, assets, property, liabilities, obligations, and responsibilities being assumed by Bloomingdale Township; and

WHEREAS, the Board of Trustees and Township Supervisor are now charged with additional duties and responsibilities in overseeing the administration of Township roads and other responsibilities formerly under the jurisdiction of the Bloomingdale Township Road District; and

WHEREAS, the electors of Bloomingdale Township previously approved by binding referendum, the creation of the Bloomingdale Township Mental Health Board; and

WHEREAS, the Board of Trustees and Township Supervisor are now charged with additional duties and responsibilities for levies, expenditures, and governance in overseeing the Mental Health Board of Bloomingdale Township; and

NOW, THEREFORE, BE IT ORDAINED that the Board of Trustees of the Township of Bloomingdale, Du Page County, Illinois, establishes annual salaries for the following offices of Bloomingdale Township officials as follows:

BE IT FURTHER ORDAINED that beginning on the fiscal year April 1, 2026 and every April 1st thereafter, that the compensation of the Supervisor, Clerk and Trustees, shall increase by either the Consumer Price Index (national CPI-U December-to-December change) as used annually to determine the property tax extension

limitation (PTELL) or 3.5%, whichever is less.

BE IT FURTHER ORDAINED that beginning on the fiscal year April 1, 2027 and every April 1st thereafter, that the compensation of the Assessor shall increase by either the Consumer Price Index (national CPI-U December-to-December change) as used annually to determine the property tax extension limitation (PTELL) or 3.5%, whichever is less.

BE IT FURTHER ORDAINED that the Clerk and Trustees shall be paid the first pay period of each month. The Supervisor and Assessor shall be paid bi-weekly.

BE IT FURTHER ORDAINED that the persons occupying the offices of Supervisor, Assessor and Clerk may be eligible for Township life, medical, dental and vision insurance, and may participate in such plans, under the same terms as the Township employees, provided however, that non-full time elected officials as defined in 50 ILCS 125/3 shall be required to pay the entire premiums associated with any medical insurance coverage in which they elect to participate.




