TAX LEVY ORDINANCE

ORDINANCE NO. 24-06

An ordinance levying taxes for police purposes for Bloomingdale Township, DuPage County, Illinois, for the tax year 2024, collectable in 2025.

BE IT ORDAINED by the Board of Trustees of Bloomingdale Township, DuPage, Illinois as follows:

SECTION 1: hereby determine and declare that the sum of One hundred sixty

eight thousand five hundred and 00/100 Dollars (\$168,500.00) are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

SECTION 2: That the amount levied for each object and purpose shall be as follows:

SECTION 4: That the Board of Trustees does hereby certify that the amount levied herein is necessary to be raised by taxation for police purposes for the <u>Bloomingdale Township Special Police District.</u>

SECTION 5: That If any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such finding shall not effect the validity of the remaining portion of this ordinance.

SECTION 6: That this ordinance shall be in full force and effect after its adoption, as provided by law.
